# **Highlights**

Funding Amount: Up to \$160,000 total costs per award (direct costs not to exceed \$100,000)

Number of Awards: Up to 8, depending on funding requested and funding available

Deadline: 11:59 p.m. EST Monday, April 28, 2025

Expected Award Date: October 1, 2025

Award Period: 12 months (or 18 months if using linked data)

# **Program Overview and Purpose**

The National Dementia Workforce Study (NDWS), sponsored by the NIH National Institute on Aging, is conducting the first large, annual surveys of the dementia care workforce in the United States. Survey data and other linked data sources will create an unprecedented resource for researchers to answer critical questions about the workforce and its impact on care and outcomes for persons living with dementia.

NDWS Pilot Award RFP, Cycle 2 (Summer 2025)

A major goal of NDWS is to build and support a community of researchers who will take advantage of this new data infrastructure to understand the dementia care workforce and its impact on care and outcomes for persons living with dementia. In keeping with this goal, this RFP seeks to develop and expand the community of researchers focused on the dementia care workforce and encourage use of the NDWS data infrastructure to advance the <a href="NIA's AD+ADRD">NIA's AD+ADRD</a> Research Implementation Milestones.

We invite researchers to submit proposals to analyze Wave 1 NDWS data that will become available by July 1, 2025. In addition to receiving direct funds, each project will have access to additional support (e.g., up to 10 hours of biostatistical consultation) from NDWS to promote successful completion and dissemination.

### **Data Availability**

Publicly available versions of NDWS survey datasets – except for the administrator surveys – will be available through the NIA-funded National Archive of Computerized Data on Aging (NACDA).

While the public use survey data may be appropriate for some research questions, NDWS is utilizing the <a href="NIA Data LINKAGE platform">NIA Data LINKAGE platform</a> for (1) sharing of the administrator survey data and (2) facilitating linkage of NDWS survey data to other data sources. Data that are available for linkage to the NDWS survey data for Wave 1 are summarized <a href="here">here</a>. More information will be available there in the coming months in preparation for Wave 1 data release by July 1, 2025.

# **Project Scope and Duration**

The Cycle 2 pilot awards will support research studies that use <u>Wave 1</u> NDWS data. Applicants may propose using multiple surveys in their analysis, but this is not required. The Cycle 2 pilot awards are designed to contribute new research findings, generate pilot data to support larger studies, and inform the development of future surveys. The Wave 1 survey data release will not contain data from the <u>Home Care Staff survey</u>; therefore, it will not be available for analysis to Cycle 2 awardees.

Applications should assume a 12-month project period beginning October 1, 2025, during which all proposed activities can be completed. If your proposed project involves use of linked data within the LINKAGE platform, you may propose an 18-month project period (to allow for time needed to gain approval to access the LINKAGE platform). Requests for no-cost extensions will be considered, particularly if there are project delays associated with applying for and obtaining access to linked data within LINKAGE; however, you should design your project to be completed within the applicable timeframe.

# **Project Examples and NIA Research Implementation Milestones**

Applications are expected to advance at least one NIA AD+ADRD Research Implementation Milestone: <a href="https://www.nia.nih.gov/research/milestones">https://www.nia.nih.gov/research/milestones</a>.

#### Examples of types of Cycle 2 projects include, but are not limited to:

- 1. Exploring the extent to which dementia knowledge and attitudes are associated with training, practice setting, and staff characteristics.
- 2. Using survey results along with Nursing Home Compare data and Payroll-Based Journal data to assess relationships between staff dementia training and attitudes, staffing and retention, and facility-level outcomes such as antipsychotic medication use.
- Determining which cognitive assessments are used most commonly in clinical practice by Community Clinicians and whether this varies by clinician and practice characteristics.
- 4. Exploring the use of specific treatments or types of care, and how this varies by clinician and practice characteristics.
- 5. Using the clinician surveys along with claims-based summary files to examine concordance between clinician-reported vs. claims-based estimates of the proportion of clinicians' patient panels that include patients with ADRD.
- 6. Assessing whether confidence in diagnosing mild cognitive impairment and dementia vary by clinician and practice characteristics.
- 7. Using claims-based summary files to examine clinician and practice characteristics associated with prescribed medication classes of interest (e.g., cholinesterase inhibitors, antipsychotics, benzodiazepines).
- 8. Using the surveys to explore whether dementia care knowledge, attitudes, and practices vary across long term care settings.
- 9. For nursing home and assisted living staff, examining to what extent formal or informal (i.e., on the job) dementia training is associated with their attitudes related to care for persons living with dementia.
- 10. Determining what training and qualifications do workers in long term care settings most frequently report. Does the educational background of LTC workers vary by race/ethnicity?
- 11. Determining what percentage of LTC personnel are immigrants and what are the most frequent countries of origin.
- 12. Examining what LTC personnel report with regard to the relationship that they have with families and how that relationship influences care.
- 13. Proposals that include psychometric research on the Wave 1 surveys.

### **Project Deliverables**

Principal Investigators will be expected to attend and present study results at an upcoming NDWS Annual Research Meeting (date and location to be determined). They also may be asked to present results in other formats, such as a webinar. Awardees will be expected to publish at least one peer-reviewed article from their study; articles may be considered for publication in the *Journal of the American Geriatrics Society* as part of an NDWS Special Collection. Awardees will be asked for study progress updates when NDWS annual reports to the NIA are due. There may be additional progress reporting requirements from NIA. Upon completion of their study, all awardees will submit a final financial report, in accordance with NIH funding guidelines.

# Eligibility

Individuals from any organization eligible for NIH funding may apply. Prior to making an award, successful applicant organizations must be registered with System for Award Management (SAM) (<a href="www.sam.gov/SAM">www.sam.gov/SAM</a>) and have a Dun and Bradstreet Universal Numbering Systems (DUNS) number.

- Principal Investigators (PI) may be any individual(s) with the skills, knowledge, and
  resources necessary to carry out the proposed research. Individuals of all disciplines
  and career stages are welcome to apply, including pre-doctoral students and those
  without a terminal degree. We encourage applications from post-doctoral fellows and
  early-career faculty who are developing or expanding a portfolio of research focused on
  the workforce that provides care to people living with dementia.
- Applicants are not required to be U.S. citizens or permanent residents.
- An individual can be part of more than one proposal but can only be a PI or Co-PI on one proposal.
- NDWS Investigators and Consultants cannot also be Pls, Co-Investigators, or Consultants on any proposal.

#### **Evaluation Criteria**

Review of the final submissions will be completed by a panel selected by the Pilot Studies Core team. The review committee will use an approach similar to that conducted in the review of NIH proposals. The review committee will use the current NIH framework for peer review.

- Factor 1: Importance of the Research (Significance, Innovation), scored 1-9
- Factor 2: Rigor and Feasibility (Approach), scored 1-9
- Factor 3: Expertise and Resources (Investigator, Environment)
  - Appropriate (no written explanation needed)
  - Identify need for additional expertise and/or resources (requires reviewer to briefly address specific gaps in expertise or resources needed to carry out the project)
- Additional factors we will consider:
  - o Addresses an AD+ADRD Research Implementation Milestone
  - o Makes use of available linked data
  - Likelihood to lead to subsequent funding

To ensure fairness in the competition we will *not* respond privately to questions. We will compile questions and answer them in a document that is posted on our website. Questions will be answered on a rolling (weekly) basis with responses posted up two weeks before the deadline. The responses will not identify individuals who submit questions. Applicants are encouraged to review the <a href="Pilot Q&A document">Pilot Q&A document</a> as well as the general NDWS <a href="FAQs">FAQs</a> prior to posing a question. Any questions already answered in the existing Q&As will not receive a response.

# **Application Process**

- Proposals will be submitted electronically through the University of Michigan-hosted Competition Space website. No separate Letter of Intent (LOI) will be required nor accepted.
- Applications must follow the application formatting instructions.
- Applications are submitted as a single PDF of all required pages/sections.
- Applications are submitted through <u>Competition Space</u> only.

- Application Timeline:
  - o Applications are due at 11:59 p.m. EST on Monday, April 28, 2025.
  - Award notifications are expected by August 1, 2025.

#### **Required Submission Materials**

To apply, please submit the following application elements in a single PDF (see details below):

- 1. Cover page
- 2. Research proposal (4-page limit, not counting references, 0.5" margins)
- 3. Budget and budget justification
- 4. NIH-style biosketches for the PI/Co-PIs and Co-investigators
- 5. Letters of support (optional)

NOTE: All necessary information should be included within the main sections of the application listed above. Do not include appendices.

#### 1. Cover Page (not included in page limit):

- Project title
- Indicate which Wave 1 survey(s) you would analyze (Community Clinician; Nursing Home Staff; Assisted Living Staff), including whether you will be using any of the administrator surveys.
- Principal Investigator's/Co-Principal Investigators' name(s), title(s), email address(es), and telephone number(s)

- Submitting organization name, address, city, state
- Names, titles, and institutions of additional project personnel (e.g., co-investigators and consultants)
- Total costs (direct + indirect)

#### 2. Research Proposal (4-page limit excluding references, 0.5" margins)

- **Specific aims:** Describe the aims and objectives that will determine the scope, depth, and overall direction of the study.
- <u>Significance:</u> Describe the importance of the problem to be addressed and its relevance to the workforce that serves people living with dementia, as well as how the study connects to the NIA milestones.
- <u>Innovation:</u> Explain how the application addresses important gaps in knowledge or challenges and/or advances current shortcomings in research on the workforce that serves people living with dementia. This can include novel concepts, approaches, or methodologies.
- Research team: Describe the Principal Investigator's and team members' backgrounds and how their training, prior research, and/or interests have prepared them to successfully complete the proposed research.
- **Approach:** Describe the overall strategy, methodology, and planned analyses. If appropriate, include feasibility, preliminary studies, potential problems, and alternative strategies.
- <u>Dissemination plan and contribution to future work:</u> Describe how this work will lead to publications, future research proposals, and impact on the field of research. The applicant should describe how the results of the pilot will lead to an application to the National Institute on Aging or other large-scale funding opportunity and the timeline for that application.

#### 3. Budget and Budget Justification (not included in page limit)

- Budgets should be prepared using the NDWS budget form available for download from the sidebar within the Competition Space platform.
- Please use October 1, 2025 as the project start date. The actual start date may differ, depending on the length of time required to establish a subaward with your institution.
   \*\*Note that the Regents of the University of Michigan will be the entity issuing the subaward.
- Awards are for 12 months in length. If you are proposing to use linked data within the LINKAGE platform, you may instead propose an 18-month timeline. Regardless, please list all costs on the single-page budget form provided (i.e., do not include a 2<sup>nd</sup> page if proposing an 18-month timeline.)
  - While no-cost extensions can be considered, we will prioritize studies that can be completed in the time frames provided in the RFA. You should design your study to be completed within the applicable timeframe.

<sup>\*\*</sup>Please note – References are <u>not included</u> in the four-page limit for this section. Please use NIH format for citations.

- The requested funding amount should be commensurate with the scope of the research plan (e.g., an analysis of surveys linked with beneficiary-level claims data might justify a larger budget than an analysis of survey data alone.)
  - Direct costs may not exceed \$100,000.
  - Total costs may not exceed \$160,000.
- Funds can be used for personnel, student fee remissions, subawards, IRB oversight fees, research-related supplies/software and equipment, publication fees, and travel (including to scientific conference(s) if the travel will provide direct benefit to the project).
  - o Please use the current NIH salary cap for any individuals over the cap.
  - Multi-site projects must adhere to the <u>NIH Single IRB policy</u> and may include Single IRB (IRB of record) oversight fees in the project budget if applicable.
- Budget must include travel for the PI to attend and present results at the NDWS Annual Research Meeting in Bethesda, MD. Allowable travel costs include airfare, lodging, meals, and ground transportation.
- A budget justification must be included, which explains the roles of individuals who will be supported and justifies all other expenses.
- Data Management and Sharing Costs <u>are not allowable</u> and must not be included in the budget or budget justification. NDWS is the only entity permitted to share NDWS data. Awardees will not be permitted to make the data they procure from NDWS available to others.

# 4. NIH-style biosketches for the PI/Co-PIs and Co-investigators (not included in page limit):

 NIH-style biosketches for the PI/Co-PIs and co-investigators who would be paid by the Award. Please ensure that each biosketch includes position/title, education/training, personal statement, positions/honors, and contributions to science.

#### 5. Letters of support (optional; not included in page limit)

**NOTE:** Protection of Human Subjects Documentation

Documentation of IRB approval will be required before funds are dispersed for any activity involving human subjects. If your proposed project involves more than one institution engaged in the conduct of non-exempt human subjects research, you must adhere to the NIH's <u>Single IRB policy</u>. If your chosen IRB of record charges fees for oversight of multi-site research, you may include these costs in your project budget.
