NDWS Overview

The National Dementia Workforce Study, sponsored by the National Institute on Aging of the NIH, is comprised of a family of surveys of the dementia care workforce in the United States. Surveys include the Community Clinician, Nursing Home Staff, Assisted Living Staff, and Home Care Staff. Researchers can use the survey data to answer critical questions about the workforce and its impact on care and outcomes for people with dementia.

Restricted-access versions of the surveys are available on the NIA-funded LINKAGE platform, while public use files (PUFs) are available through National Archive of Computerized Data on Aging – Open Aging Repository (NACDA-OAR).

NDWS Wave 1 Data Collection Protocol

Community Clinicians

The Community Clinician (CC) sample was drawn from the sampling frame constructed from the National Plan and Provider Enumeration System (NPPES) database of clinicians who have a National Provider Identifier (NPI). In addition to the list of NPIs, we used data from CMS (see the Wave 1 CC sample from overview on the NDWS.org website) to identify clinicians with specific licensures and specialties who have treated a person with a dementia diagnosis recorded in Medicare claims data. This yielded a list of 492,186 eligible clinicians from which a sample of 25,000 was drawn. Between August 2024 and April 2025, the sample of 25,000 CCs were invited to complete a 25-minute Web survey via a series of mail and email invitations and reminders. Non-responding CCs received telephone calls as part of the non-response follow up effort. In addition to Web, CCs were offered an option to complete the NDWS survey using a paper-and-pencil (PAPI) instrument. Data collection results are presented below.



Nursing Homes and Assisted Living Communities

For Nursing Homes (NH) and Assisted Living Communities (AL) a two-stage sample design and data collection approach was used. In the first stage, samples of 200 organizations for each of the NH and AL surveys were selected from separate sample frames. All 50 states and the District of Columbia were included in these frames. Sampled organizations were contacted via mail, email, and phone. An administrator with the knowledge and authority needed to complete the survey was identified in each sampled organization and asked to complete an organization-level survey and to provide a roster of their staff relevant to care for dementia residents. In the second stage, the staff rosters were sampled, and the selected individual staff members were invited to complete a 20 - 25 minute Web survey via a series of mail and email invitations and reminders. Non-responding staff members received telephone calls as part of the non-response follow-up effort. In addition to Web, sampled staff were offered an option to complete the NDWS survey using a paper-and-pencil (PAPI) instrument. Data collection results are presented below.
